**1. CALL TO ORDER**

Mayor Tony McKnight called the meeting to order at 7:00 p.m.

**b) INVOCATION AND PLEDGE OF ALLEGIANCE TO THE AMERICAN FLAG.**

Councilmember Gordon Cole gave the invocation and Councilmember Billie Petty lead the pledge of allegiance to the American flag.

Councilmember Gordon Cole made a motion and Councilmember Robert Kalka made a second to approve appointing Clint Smith to the vacant council seat for the remainder of the 2024-2025 term.

The seat will be placed on May 2, 2026, election ballot for the 2025-2026 parts of the term. The motion carried unanimously.

If the mayor determines that the request is urgent, he will approve the work and notify the council at the next council meeting. The motion carried unanimously.
