

ORDINANCE NO. 93-02

AN ORDINANCE OF THE CITY OF WELLS, TEXAS ESTABLISHING CLOSING OF CITY PARKS AT 11:00 P.M. AND PROHIBITING MOTORIZED VEHICLES IN CITY PARKS AT ANY AND ALL TIMES AND PROVIDING A PENALTY FOR VIOLATIONS.

WHEREAS, because activity at City Parks can interfere with the enjoyment of public and private property, the general welfare requires that the City Council establish a closing time of 11:00 P.M. at the City Parks; and

WHEREAS, because motorized vehicles in City Parks pose a safety hazard to the public, the general welfare requires that the City Council prohibit all motorized vehicles in City Parks.

NOW THEREFORE:


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WELLS, TEXAS:

SECTION 1. The Mayor or his designee is hereby authorized and directed to implement the provisions of the Ordinance to protect public interests and welfare.


SECTION 2. The provisions of this Ordinance shall apply to the general public in the City of Wells.

SECTION 3. Any person who violates or fails to comply with this Ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be punished by a fine not to exceed \$500.00 plus court cost.

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF WELLS, TEXAS COUNTY OF CHEROKEE, TEXAS. EXERCISING THEIR DISCRETION TO AMEND ORDINANCE NO. 93-02.

AN ORDINANCE OF THE CITY OF WELLS, TEXAS ESTABLISHING CLOSING OF CITY PARKS AT 11:00 P.M. AND PROHIBITING MOTORIZED VEHICLES IN CITY PARKS" AT ANY AND ALL TIMES AND PROVIDING A PENALTY FOR VIOLATIONS.

BY ADDING/REPLACING THE FOLLOWING:

1. SUMMER HOURS WILL BE FROM 7:00 AM TO 11:00 PM
2. WINTER HOURS WILL BE FROM 7:00 AM TO 10PM
3. BIRTHDAY PARTIES AND EVENTS CAN ONLY BE HELD AT THE DEPOT PORTION OF THE PARK WITH THE PARTY BOOKING WITH CITY HALL PRIOR TO THE PARTY.
4. ALL EVENTS/BIRTHDAY PARTIES ARE RESPONSIBLE TO KEEP THE AREA CLEAN OF DEBRIS, TRASH MUST BE BAGGED AND PLACED IN THE AVAILABLE TRASH CARTS. ALL PARTY DECORATION MUST BE REMOVED.
5. CONSUMPTION OF ALCOHOLIC BEVERAGES IS ALWAYS PROHIBITED ON CITY PROPERTY.
